Does your business generate two or more cubic yards of solid waste per week? If so, California State Law requires you to have an organic waste recycling program.

**Donating surplus food is one way to comply.
We can help – no charge.**

About the Laws

AB 1826 requires California businesses that generate two+ cubic yards of solid waste per week to establish an organic waste recycling program. **SB 1383** establishes guidelines for organic waste reduction and edible food recovery targets for businesses.

Donating surplus food is one way to comply with AB 1826 and SB 1383.

Who should sign up to donate?

Any permitted food facility can be a donor, such as wholesalers, supermarkets, restaurants, cafes, hotels, universities, farmers, and farmers' markets.

Why should I donate my excess food?

- Comply with **state laws**.
- **Receive tax deductions** for donated food.
- **Reduce cost** of hauling away food waste.
- **Feed community members** in need.
- Increase community engagement and **positive publicity**.
- **Divert waste** from landfills.

Am I liable if I donate my excess food?

No. If the excess food is wholesome and fit for human consumption, and is donated to a nonprofit that is feeding individuals in need, the donor is not liable. For more details visit sbfoodrescue.org/related-laws.
